The principal aims of the Society are the study, understanding, recording and conservation of minerals and mineralogical sites. The Society works closely with museums and other like-minded organisations in the pursuit of these aims. The wide spectrum of membership ranges from beginners to professional mineralogists and geologists. 'Hands-on' experience with mineral specimens is encouraged and the Society encourages responsible collecting and exploration.

The Russell Society Application Form



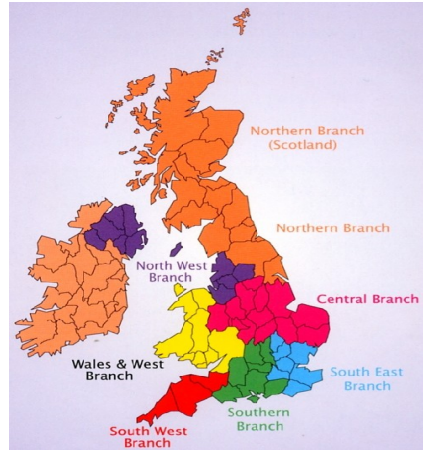
There are four levels of subscription membership: Ordinary, Family, Student and Junior. Student members are over 18 years and must be in full-time education. Junior members can join at the age of 14 years but must transfer to Student or Ordinary membership at the age of 18 years. Family membership entitles a family to full Ordinary membership, the difference being that only one copy of the Journal, Newsletter and any other documents will be circulated to each family. Family membership can also include children up to the age of 18 years, when they should transfer to Ordinary or Student membership.

Currently about 500 members are spread throughout the United Kingdom as well as overseas. The Society is organised into seven branches: Northern, North-West, Central, Wales and West, Southern, South East and South West. Each branch of the Society organises an annual programme consisting of:

- Field trips and excursions to sites of mineralogical and geological interest.
- Indoor meetings with presentations by invited guest speakers or members, practical demonstrations and social events.

About fifty field trips and forty winter meetings take place each year, making the Russell Society programme one of the most extensive and varied of any comparable society in this country. Any member can attend any meeting.

Visitors are also most welcome; please let us know if you wish to attend any of our field trips or indoor meetings.



The springtime Annual General Meeting weekend is organised by each branch in rotation. In addition to the AGM and dinner, this weekend usually includes field trips, formal symposia, informal discussion and mineral swapping sessions. There is always a free exchange of ideas and knowledge between members at these meetings.
